EFPOA BOARD ELECTIONS

Due to concerns over the receipt and handling of election nomination resumes received for the annual EFPOA Elections, the Board of Directors determined at their June 5, 2010 Regular Board meeting that it is necessary to provide a revised election timeline this year. The purpose of this extended nomination resume deadline extension is to insure that any and all interested community members have the opportunity to be included on the election ballot, and to ensure that the EFPOA Annual Election Procedure is followed completely. However, please take note that this nomination resume extension will create a much tighter timeline to SUBMIT, RECEIVE, REVIEW and COMPILE/MAIL election ballots.

If you are interested in running for the EFPOA Board of Directors, please submit your nomination resume of 200 words or less to the **EFPOA Election Committee, P.O. Box 40, Waters, Michigan 49797-0040**. Please pay special attention to the revised submission timeline:

Resumes must be received no later than JUNE 15, 2010 at the Waters, Michigan Post Office by close of business.

Only resumes received by U.S. Mail will be accepted.

Following the receipt of resumes, the Election Committee will prepare candidate information sheets and ballots for each lot owner. **The candidate information sheets and ballots will be prepared and mailed on June 16, 2010. Ballots must be returned and received via US Mail on or before June 30, 2010.** Only members in good standing as of May 28, 2010 will be allowed to cast a ballot. A member in good standing means that your Maintenance Dues are paid in full and your good standing status has not been revoked. Association members can vote for up to three candidates.

The ballots will be marked with a six-digit number. This is for security and verification purposes only. These numbers do not represent lot numbers and are not a means of tracking any lot owner's vote.

PLEASE MAKE SURE YOUR VOTE COUNTS BY VOTING FOR ONLY THREE CANDIDATES AND PLEASE DO NOT ALTER, DEFACE, OR DESTROY THE SIX-DIGIT NUMBER AT THE BOTTOM OF THE BALLOT.

- ✓ *Only resumes received by U.S. Mail will be accepted.*
